Responsibilities and Duties

- Perform initial patient pre-operative screenings, history and physical examinations
- Analyze lab values and diagnostic tests; determine the need for follow-up appointments and further treatment options
- Address post-surgical issues that could arise such as hematoma or seroma evacuation, identify infections, chemosis and perfusion issues with facial plastic surgery patients; identify appropriate treatment including prescribing for each situation
- Determine effectiveness of treatment plans with documentation of patient care outcomes
- Provide ongoing patient education pre-operatively and post-operatively
- Make appropriate referrals to other healthcare professionals and community agencies
- Serve as the resource patients need for ongoing care information, counseling and provide guidance for any patients with critical conditions
- Obtain medical clearance as appropriate for complex medical health history patients
- Prescribe pharmacologic agents and non-pharmacologic therapies
- Perform safe removal of sutures, drains, staples and dressings | bolsters

- Assists physician with excision of hair for follicular unit transplants
- Harvests grafts using Follicular Unit Excision (FUE) method
- Sets up equipment for placement and ensures grafts are handled and chilled appropriately and counts are accurate
- Prepares scalp for the placement of grafts using slits or stick and place
- Places grafts according to physician's plan
- Assists with administration of oral medications and local injections if needed

- Assists with application of dressing for FUE patient
- Educates patient throughout the procedure about the ongoing process
- Review of hair logs, patient charts and photos for quality control on a regular basis
- Maintains knowledge of current literature regarding hair loss and treatments
- Learns the techniques of graft handling, preservation as well as incisional placement
